

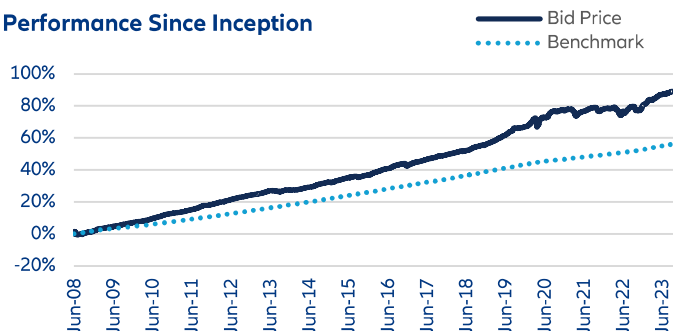
# Allianz Life Master Bond Fund

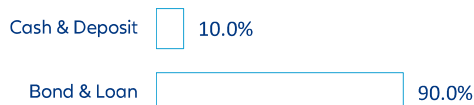
## Investment Objective
