

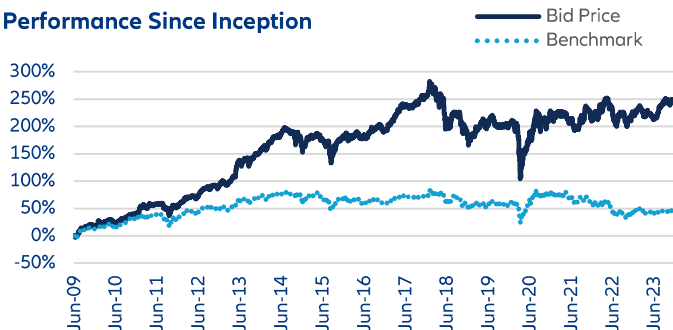
# Allianz Life Master Dana Ekuiti

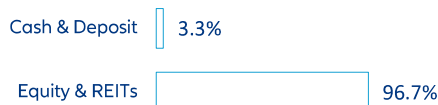
## Investment Objective
