

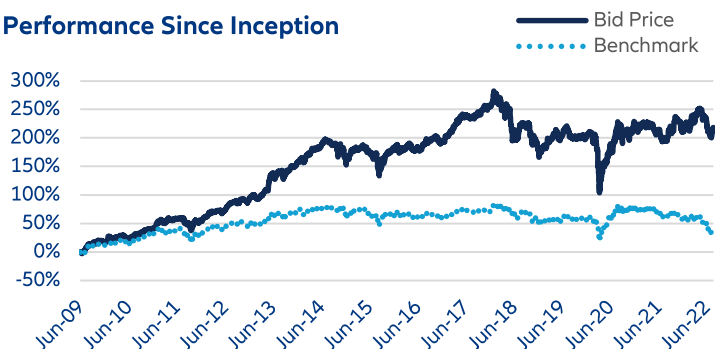

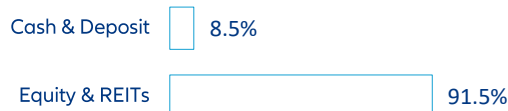
## Investment Objective
