

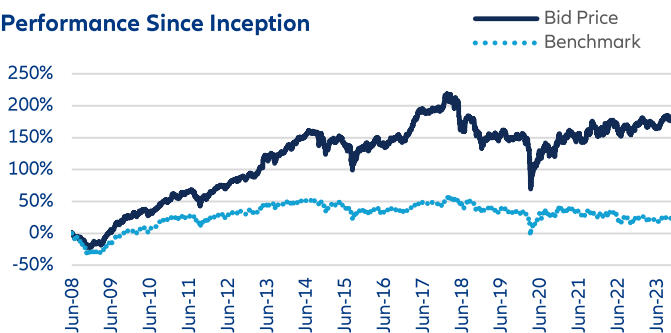
# Allianz Life Master Dividend Fund

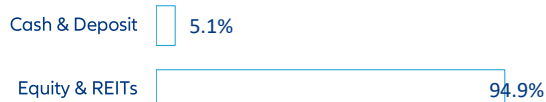
## Investment Objective
