

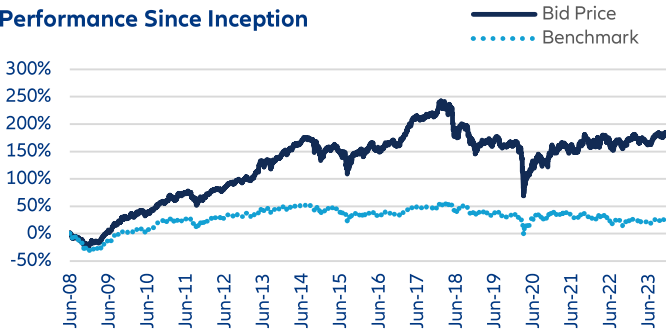

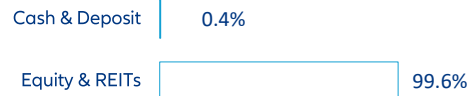
Investment Objective
