

## **"Kenal Pasti 6 Perbezaan" Contest Terms & Conditions**

"Kenal Pasti 6 Perbezaan" contest ("**Contest**") is jointly organised by Allianz Life Insurance Malaysia Berhad ("**ALIM**") and Allianz General Insurance Company (Malaysia) Berhad ("**AGIC**") (collectively, "**Organisers**") for eligible individuals who fulfil the requirements of this Contest to stand a chance to win a badminton racquet, subject to the terms and conditions of this Contest herein ("**Terms and Conditions**").

### **Part A: Contest Period**

1. This Contest will run from 21 October 2022, 10:00am to 4 November 2022, 11:59pm, both dates and times inclusive ("**Contest Period**").
2. Unless the Contest Period is extended, any participation/entry beyond the Contest Period due to any reason whatsoever will not be considered and will automatically be disqualified from the Contest.

### **Part B: Eligibility**

1. This Contest is open to all citizens and permanent residents of Malaysia who are of the age of eighteen (18) and above and hold a valid National Registration Identity Card (NRIC) or Permanent Resident Identity Card (MyPR) issued by the National Registration Department of Malaysia at the time of participation of the Contest, EXCEPT for:
  - i. Employees of ALIM, AGIC or Allianz Malaysia Berhad (collectively, "**Allianz Group of Companies**"), whether employed on a permanent or contractual basis;
  - ii. Agents, financial advisors and brokers of Allianz Group of Companies; and
  - iii. Vendors, suppliers, advertisers, and contest agents of Allianz Group of Companies who are directly or indirectly involved in organising this Contest and their employees.

### **Part C: Steps to Participate in the Contest**

1. To participate in this Contest, each contestant ("**Contestant**") must complete the following steps ("**Steps**") during the Contest Period:

#### **Step 1**

- Spot all the differences between two images posted on Allianz Malaysia's Facebook page.

#### **Step 2**

- Take a screenshot of the images and circle all the differences between the images. Then, share it in the comment section of the Facebook post together with a statement of why badminton is the Contestant's favourite sport (limited to 20 words only).
2. Each Contestant is only entitled to one (1) entry to the Contest regardless of the number of submissions or comments made by the Contestant on the Facebook post.
  3. The Contestants must enter this Contest via their own registered Facebook accounts. Entries submitted on behalf of another person and joint submission of entries are strictly prohibited.
  4. Any statement or comment made by the Contestants on the Allianz Malaysia's Facebook post for purposes of this Contest shall not use or contain any language, content or material which is illegal, derogatory, obscene, or otherwise deemed inappropriate, at the sole discretion of the Organisers. The Organisers reserve the right to remove any statement or comment which is deemed inappropriate or is not compliant with the Terms and Conditions of this Contest.

5. Failure to comply with any of the Steps and the Terms and Conditions shall automatically render the relevant entry invalid and result in the disqualification of the relevant Contestant.

#### **Part D: Prizes and Selection of Winners**

1. Twenty (20) qualified Contestants will be selected as winners ("**Winners**") by the Organisers at their absolute discretion based on the following criteria:
  - Screenshot Photo: Contestants who circle all differences of the images correctly
  - Personal Twist: Contestants who share the most interesting comment of why badminton is their favourite sport.
2. Each Winner will receive one (1) unit of Yonex brand badminton racquet ("**Prize**").
3. Announcement of Winners will be posted on Allianz Malaysia's Facebook and Instagram pages within sixty (60) calendar days from the last day of the Contest Period i.e 4 November 2022, 11:59pm. To claim for their Prizes, Winners will need to send an email to [ajbc@allianz.com.my](mailto:ajbc@allianz.com.my) within seven (7) calendar days once the announcement is posted, with the following details:
  - Name as per NRIC or myPR
  - NRIC or myPR number
  - Mobile number
  - Mailing address (only for Contestants residing outside of Klang Valley)
4. If any of the Winners does not or fails to email the Organisers within that stipulated period, the Organisers reserve the right to forfeit the Prize or to assign the Prize to another qualified Contestant who will be deemed as the new winner. In the event the particulars provided by a Winner are invalid or incorrect, the Organisers will not be held liable for any failure of or delay in his receiving the Prizes.
5. Each Winner is entitled to receive one (1) Prize only.
6. The Prize is not transferable to any person nor exchangeable for cash.
7. This Contest is not sponsored, endorsed, administered by or associated with Yonex or any Yonex suppliers.
8. The Organisers reserve the absolute right to change and/or substitute the type and number of prizes for this Contest at any time without prior notice.
9. For Contestants residing within Klang Valley, collection of Prizes is to be made at the Allianz Junior Badminton Championship (AJBC) 2022 Grand Finals at Stadium Juara, Bukit Kiara on 26 November 2022 between 10am and 3pm. All costs and expenses incurred for the collection of the Prizes, if any, shall be solely borne by the Winners.
10. The Organisers reserve the right to postpone the aforesaid date for Prize collection to a later date in the event of any unforeseen circumstances.
11. The Organisers shall not be liable for any losses or damages which occur during the Prize collection or delivery process. No replacement and/or exchange of Prize will be entertained.

## Part E: General Provisions

1. By participating in this Contest, the Contestants shall be deemed to have understood and agreed to be bound by the Terms and Conditions and any decisions made by the Organisers in respect of the Contest.
2. The Organisers reserve the right and has the absolute discretion to:
  - i. vary these Terms and Conditions or the Contest Period, suspend, cancel or terminate the Contest with or without any prior notice or reason. For the avoidance of doubt, such cancellation, termination or suspension or variation by the Organisers shall not entitle the Contestants to any claim or compensation against the Organisers for any and all losses or damages incurred as a direct or indirect result of the act of cancellation, termination, suspension or variation; and
  - ii. disqualify any of the Contestants and forfeit their Prizes in the event of non-compliance by the Contestants with any of these Terms and Conditions or if the Organisers have a reason to believe that the Contestant has attempted to undermine the operation of this Contest in any way whatsoever including but not limited to fraud, cheating, or deception.
3. The Organisers shall not be liable for any loss or damage of any kind howsoever arising from or suffered by any Contestant in connection with their participation in this Contest.
4. Any decision made by the Organisers in respect of this Contest including the disqualification of Contestants, selection of Winners and the determination of Prizes shall be final and absolute, and no complaints or appeals or related correspondence will be entertained.
5. By participating in this Contest, the Contestants shall be deemed to have consented to allow their personal data being collected, processed and used by the Organisers in accordance with the Personal Data Protection Act 2010 and for the following purposes:
  - i. Operations and administrative process of this Contest;
  - ii. Update Allianz Group of Companies' records;

  - v. Any purposes required by law or regulation.

  - iii. the photograph(s) and/or video(s) of the Winners.
