## Allianz Life Global Income Fund



### Manager's Comment (For Allianz Global Income- USD)

#### Market Commentary

- Markets digested positive US economic data, a less accommodative US Federal Reserve (Fed), yield curve flattening, COVID-19 resurgence concerns, and US fiscal policy developments.
- Most US reports suggested continued economic strength. Unemployment declined, leading indicators increased, and consumer
  confidence surpassed estimates. On the other hand, housing statistics were mixed, and November's consumer price index (CPI)
  report showed inflation hitting the highest level since 1982.
- As widely expected, the Fed doubled the monthly pace of asset purchase tapering to USD 30 billion. Additionally, the median interest
  rate forecast showed three hikes in both 2022 and 2023, followed by a slower cadence in 2024. Elevated investor angst heading into
  December's Fed meeting eased after uncertainty was removed.
- In this environment, US Treasury yields rose across the curve. A sharper move at the short end caused the curve to flatten. At period-end, the 3-month, 2-year, 5-year and 10-year yields finished at 0.05%, 0.73%, 1.26%, and 1.50%, respectively\*.
- COVID-19 resurgence concerns increased on Omicron-related headlines as the strain showed to be more contagious than other variants but also less severe. The US Food and Drug Administration's (FDA's) emergency use authorisation of an oral antiviral candidate helped reduce some concern.
- Congress passed legislation to raise the debt limit, mitigating a short-term market risk. On the other hand, President Biden's "Build Back Better" bill stalled after senator Joe Manchin opposed the package.
- Against this macro backdrop, asset class performance was bifurcated with risk assets generally advancing, while core fixed income
  declined. Global equity markets, as measured by the MSCI World Index, returned +4.27%.\*\* Non-US developed stocks rebounded
  sharply in December and slightly outpaced their US counterparts. Convertible securities finished unchanged and new issuance
  slowed due to seasonal factors. Global high-yield bonds recovered the prior period's loss, helped by a gain of +1.88% from US issues,
  according ICE. Like the convertible market, US primary market activity slowed month-over-month with seasonality. Global fixed
  income, as measured by the Bloomberg Global Aggregate Index, returned -0.14%.^ US core bonds lagged non-US core bonds.

#### Market Outlook and Strategy

- The Fund returned positively for the month. Equity exposure was the primary driver of performance, followed by high-yield bond holdings. Convertible security exposure was also beneficial, while the core fixed income allocation was a modest detractor in the period. Top contributing positions included a mobile handset maker, a semiconductor company, and a professional services provider. Holdings with exposure to Software, Pharmaceuticals, and Semiconductors detracted the most from performance.
- US economic expansion is expected to continue in 2022. Growth catalysts include steadfast consumer demand driven by rising wages, deposits, and employment, and record household wealth. The potential for higher business spending and the possibility of additional US fiscal stimulus are also supportive.
- Against this backdrop, revenues and corporate profits should improve on a year-over-year basis. US companies are positioned to benefit from pricing power, operating leverage, and rising sales, which should more than offset the impact of higher input costs and wages and near-term supply bottlenecks.
- Persistently high inflation and tighter-than-expected monetary policy are key risks. Despite a tighter Fed, the US economy should continue to expand because of strong underlying forces and above-trend gross domestic product (GDP) growth expectations. Additional risks include COVID-19 related setbacks, geopolitical developments, and the outcome of US midterm elections, among others.

# Investment Strategy & Approach
