

#### Manager's Comment (For Allianz Total Return Asian Equity- USD)

#### Market Commentary

- Equity markets in Asia delivered mixed returns in March. Overall, the stronger tone to the US dollar and the US Federal Reserve's (Fed's)
  rate hike dampened returns across the region. China stocks suffered sizeable losses. Large cap tech stocks were hurt by concerns that
  their American depositary receipts (ADRs) may be forced to de-list from US exchanges. Additionally, as COVID-19 cases surged to their
  highest levels since the start of the pandemic, the key cities of Shanghai and Shenzhen entered lockdowns, raising the prospect of
  further supply chain disruptions. Purchasing managers' indices (PMI) for March are already showing the impact of the government's
  COVID-19 restrictions, with both manufacturing and services activity contracting for the first time in almost two years.
- Elsewhere, Korea and Taiwan ended the month with relatively flat returns. ASEAN markets generally outperformed. Energy exporter Indonesia performed the best as oil prices pushed higher.

#### Market Outlook and Strategy

- The Fund lagged the benchmark during the month. From a country perspective, stock selection in Taiwan, China and Korea accounted for the underperformance. From a sector perspective, stock selection in Financials, Real Estate and Information Technology weighed on returns.
- On a single stock basis, our overweight positions in Reliance Industries (Indian oil & gas refining & marketing), an Indonesian bank, and a Taiwanese semiconductor company helped most.
- Conversely, our positions in a real estate operator, a restaurant chain operator and Tencent, detracted.
- During the month, we liquidated our holdings in a Taiwanese electronic components company, and a Chinese interactive home entertainment provider. In addition, we added a Singaporean bank to the portfolio.
- At the end of the month, the top holdings were Taiwan Semiconductor, Samsung Electronics and Tencent. The largest overweight positions were in two India companies, HDFC Bank and Reliance Industries, as well as Kweichow Moutai, a Chinese white liquor company.
- Overall, the Fund has an overweight position to Singapore and China/Hong Kong and is underweight Korea and Malaysia. At a sector level, the Fund is overweight Communication Services, Financials and Consumer Staples spaces, whilst underweight Materials, Utilities and Industrials sectors.

### Investment Strategy & Approach

The investment approach would be a combination of 1) Top down analysis of the macroeconomic environment to determine asset allocation and sector exposure strategy and 2) Rigorous bottom up analysis which includes value analysis and financial analysis, to select individual stocks/credits to generate alpha return.

On top of regulatory limits imposed by Bank Negara Malaysia, Allianz Life have put in place tight internal investment limits for all asset classes to ensure that the Fund does not take on excessive risk, while recognizing there cannot be total elimination of risks associated with investing in the Fund. The following is a non-exhaustive list of key risk factors when investing into the Fund.

- Market Risk The value of the Fund's investment assets may be affected by changes in economic fundamentals, interest rate movement, regulatory policy, political and industrial developments. These market factors may result in fluctuations in the value of the Fund's investment assets. This risk may be mitigated by ensuring a rigorous review of macroeconomic factors and asset allocation strategy.
- **Country/Foreign Investment Risk** This risk refers to the risks of investing in foreign markets. The value of the foreign investment assets directly or indirectly held by the Fund may be affected by country-specific factors, such as the country's economic fundamentals, social and political stability and regulatory policy. While we would make every effort to ensure that the objectives of the Target Fund are appropriately aligned with those of ours, we do not have control over the Target Fund Manager's investment in terms of its approach, intelligence, operations and management. In the unlikely event of any mishandling of the Target Fund, the NAV of our Fund, which is investing predominantly into the Target Fund, could be similarly adversely affected. This risk may be mitigated by our constant monitoring of the Target Fund, which is requisite to ensuring that the Target Fund's objective, risk profile and characteristics are in line with ours.
- Target Fund Subscription/Redemption Time Lapse Risk Due to the inherent unitisation and Target Fund subscription/redemption processing times, there could be a time lapse between the time monies are received by the Fund and the time the monies are subsequently invested into the Target Fund, vice versa for redemption. The risk of unnecessary subscription/redemption time lapse may be minimised by our best efforts in optimizing the process while adhering strictly to the stipulated asset allocation.
