

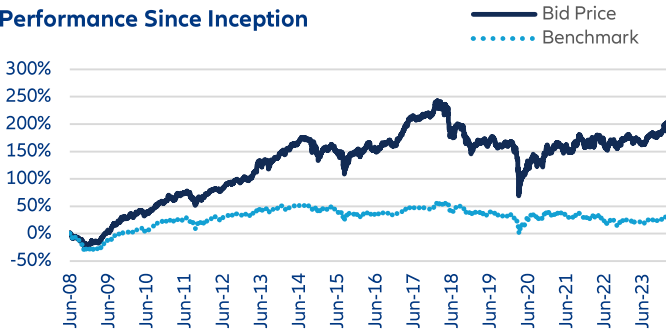
# Allianz Life Master Equity Fund

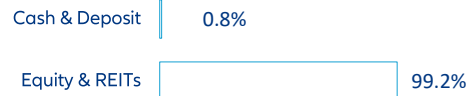
## Investment Objective
