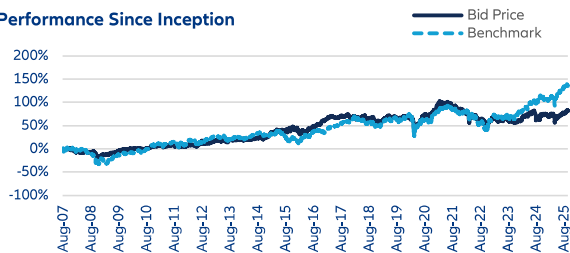

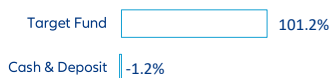

## Portfolio Composition by Asset Type



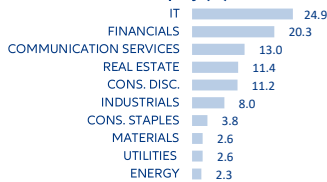

### Sector Allocation - Equity (%)



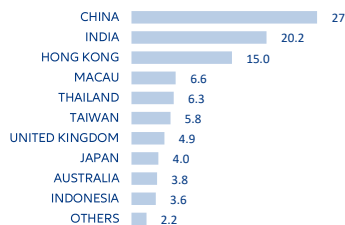

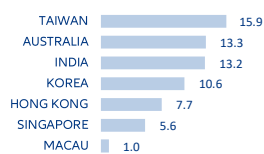
