Investment Objective

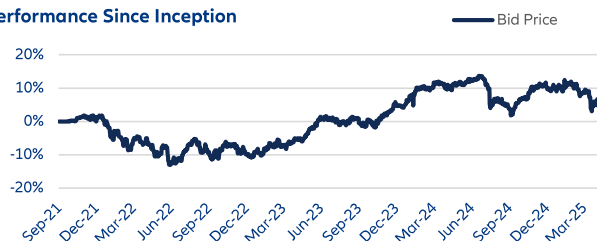

Portfolio Composition by Asset Type

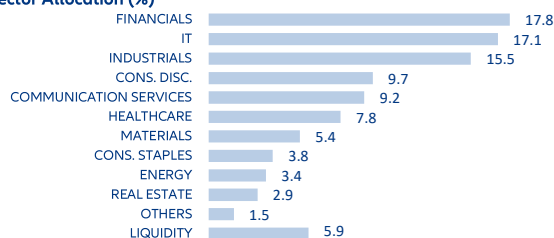

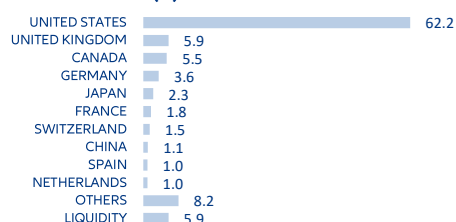
