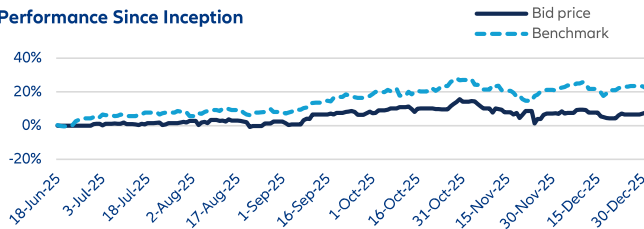

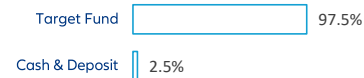

## Portfolio Composition by Asset Type

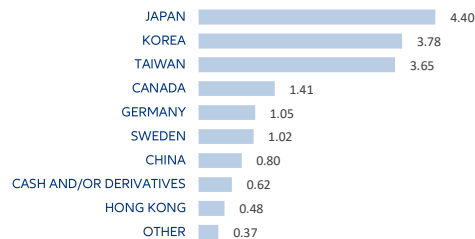

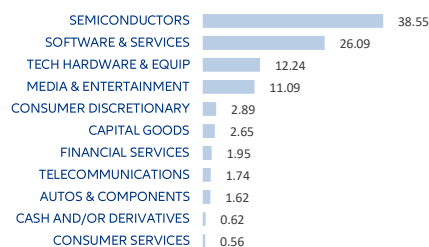
