

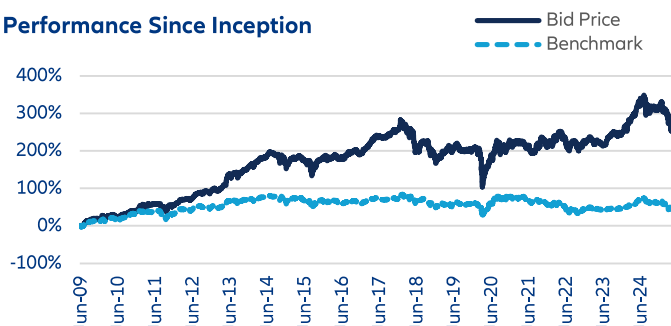

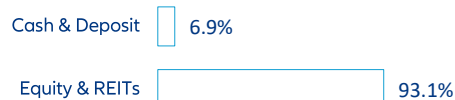
Investment Objective
