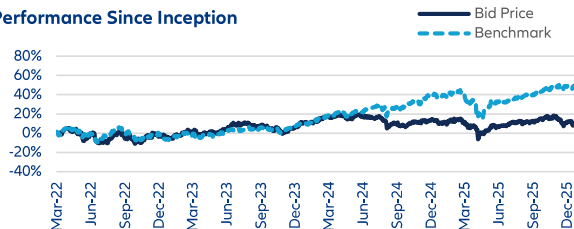

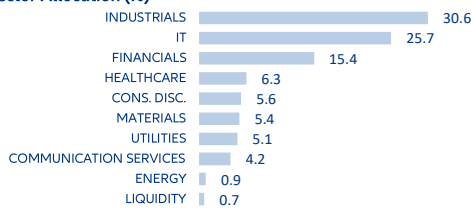

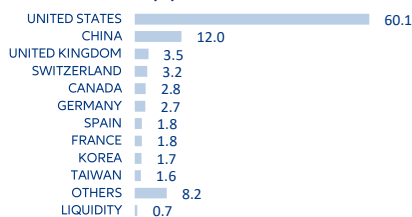

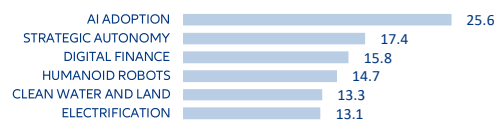
Sector Allocation (%)
