## Investment Objective

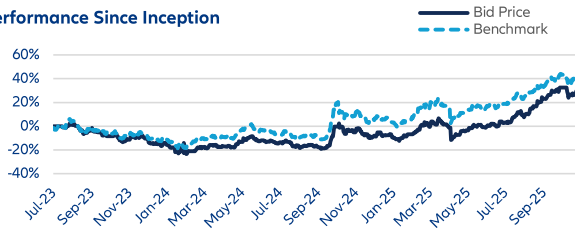

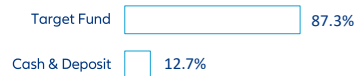

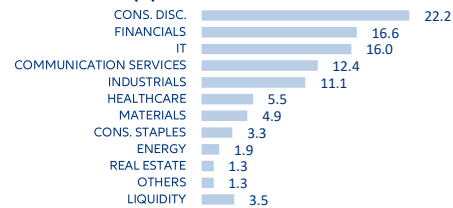

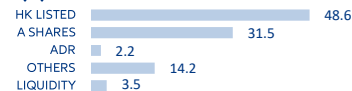
