## Investment Objective

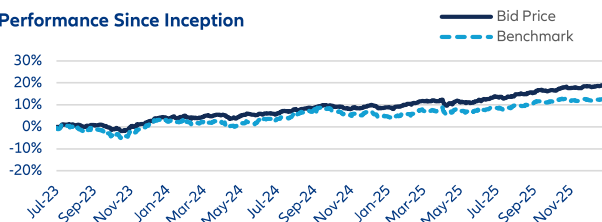

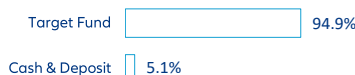

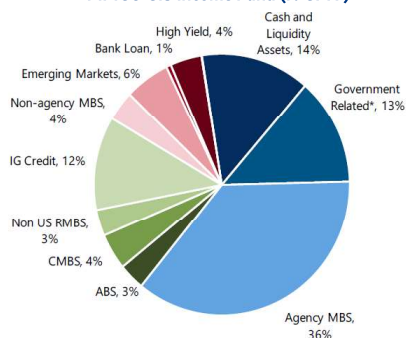

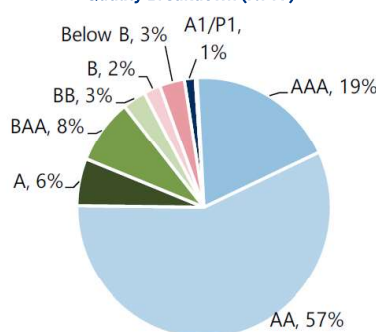
