## Investment Objective

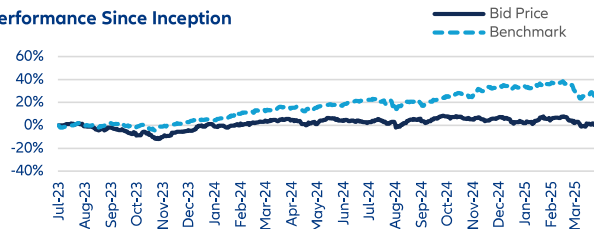

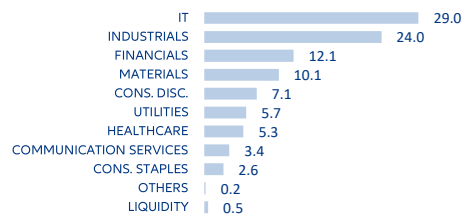

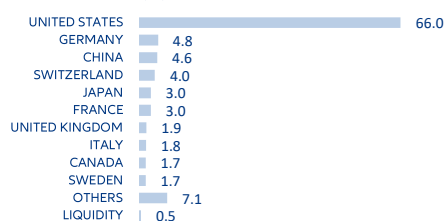
