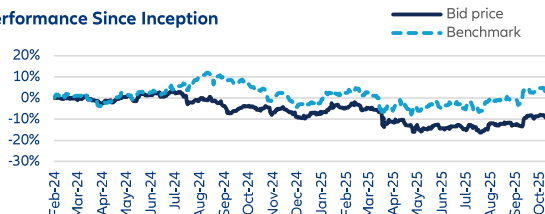

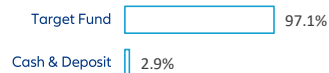

Portfolio Composition by Asset Type

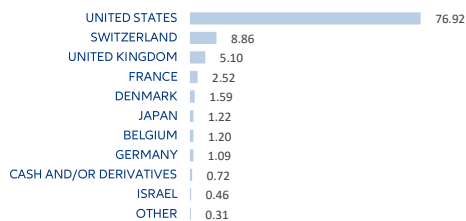

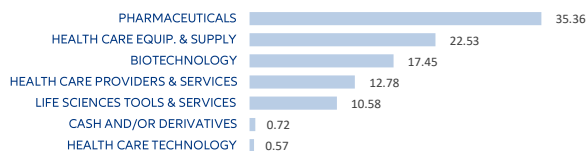
Geographic Breakdown (%)
