Investment Objective

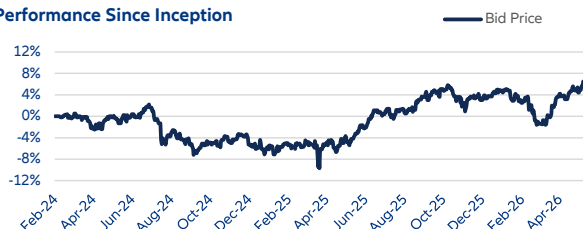
