Investment Objective

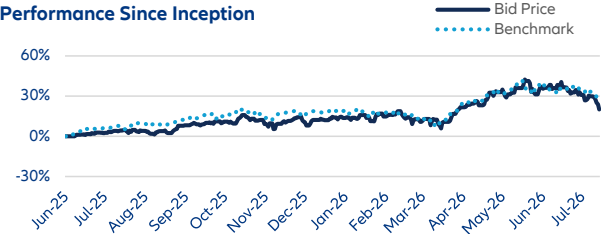
