The Allianz Life Global Unconstrained Equity Fund (MYR-Hedged) (the "Fund") seeks to achieve long term capital growth.

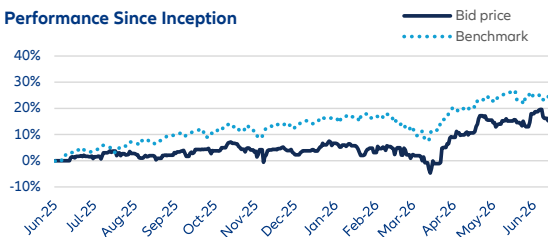

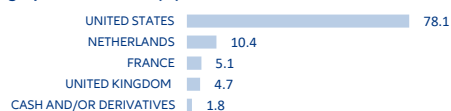

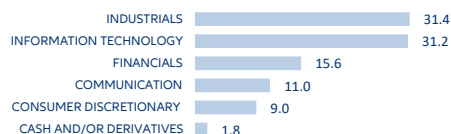
