## Investment Objective

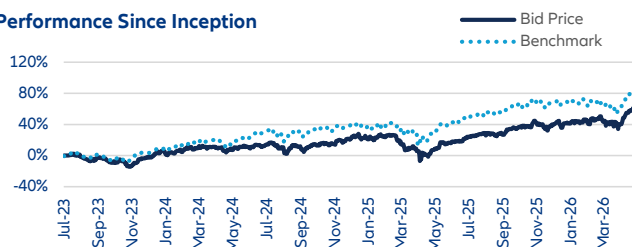

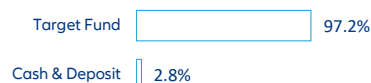

## Portfolio Composition by Asset Type



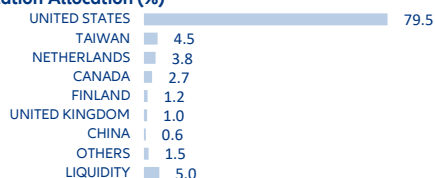

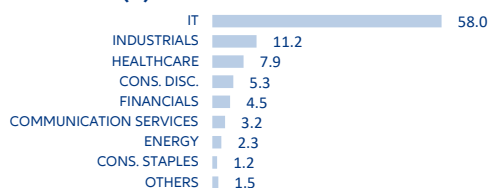
