

Allianz 25th Anniversary Campaign Terms and Conditions

The Allianz 25th Anniversary Campaign (“**Campaign**”) is organised by Allianz Life Insurance Malaysia Berhad and Allianz General Insurance Company (Malaysia) Berhad (collectively, “**Allianz Malaysia**”), subject to the terms and conditions herein.

Part A: Campaign Period

- This Campaign will run from 1 January 2026 to 31 July 2026, both dates inclusive (“**Campaign Period**”), and will consist of 2 Campaign Bursts as follows:

Campaign Burst 1 (“ Burst 1 ”)	1 January 2026 – 30 April 2026
Campaign Burst 2 (“ Burst 2 ”)	1 May 2026 – 31 July 2026

- The cut-off time and date to participate in this Campaign is at 23:59pm (Malaysia time) on 31 July 2026.
- Allianz Malaysia may at its absolute discretion shorten or extend the Campaign Period at any time with or without any prior notice. Unless the Campaign Period is extended and announced by Allianz Malaysia, any participation beyond the Campaign Period will be disregarded.

Part B: Eligibility

- This Campaign is open to all citizens or permanent residents of Malaysia who are at least eighteen (18) years old and who fulfil the following conditions (“**Eligible Criteria**”):

Allianz Life

- New individual customers of Allianz Life Insurance Malaysia Berhad (“**Allianz Life**”) who purchase any of the following products of Allianz Life insurance (“**Eligible Allianz Life Products**”) during the Campaign Period and payment via direct debit authorisation, subject to Allianz Life’s underwriting requirements, and provided that the policy is issued within the Campaign Period and remain in force with the 15-day free-look period;
- For the avoidance of doubt, any Eligible Allianz Life Product purchased during the Campaign Period where the 15-day free-look period has not ended by 30 April 2026 for Burst 1 and/or 15 August 2026 for Burst 2 will NOT be eligible to participate in this Campaign;

- (iv) Existing customers of Allianz Life (as defined below) having an active Allianz Life individual policy who purchase any of the Eligible Allianz Life Products and/or Eligible Allianz General Products or existing customers of Allianz General (as defined below) having an active policy who purchase any of the Eligible Allianz General Products and/or Eligible Allianz Life Products, as at 30 April 2026 for Burst 1 and/or 31 July 2026 for Burst 2; and

AND

- (v) New Customers and Existing Customers who have registered as the user of the MyAllianz customer portal application (“**MyAllianz**”) by 30 April 2026 at 23:59pm for Burst 1 and/or 31 July 2026 at 23:59pm for Burst 2.

2. For the purposes of this Campaign, the status of customer is defined as follows:
- a. **New Customer** means new customers of Allianz Life or Allianz General who do not have an active policy with Allianz Malaysia as of 1 January 2026. This includes individuals who have never been insured by Allianz Life or Allianz General as well as those whose previous policies were inactive or expired prior to the aforementioned date.
 - b. **Existing Customer** means existing Allianz Life or Allianz General customers who holds an active policy with Allianz Life and/or Allianz General as of 31 December 2025. This includes all customers with policies that are active and in force as of the aforementioned date, regardless of the type or duration of the policy.

Part C: Campaign Participation

1. New and/or Existing Customers who fulfil the Eligible Criteria (“**Eligible Participants**”) and wish to participate in this Campaign must complete the following actions

- a. Visit the campaign webpage at [<https://www.allianz.com.my/personal/whats-new/25anniversary.html>].
 - b. Register by completing the form with full name as per National Registration Identity Card (“**NRIC**”), NRIC number, email address, mobile number and state of residence.
 - c. Answer the designated question correctly.
 - d. Read and agree to the terms and conditions by ticking the consent box. Then, click “Submit” to complete the Registration Process (“**Qualifying Criteria**”).
 - e. Register for a MyAllianz account if it has not yet been done.
2. By participating in this Campaign, Eligible Participants will earn Campaign Entries (“**Entries**”) as follows:

Part D: Prizes

1. A total of fifty (50) prizes (“**Prizes**”) will be awarded across two (2) Bursts, comprising two (2) Grand Prizes and forty-eight (48) Special Prizes, as detailed in the table below. The Grand Prizes and Special Prizes are collectively referred to as the “**Prize(s)**”.

Part E: Winner Selection, Announcement and Notification

1. Winners Selection

- a. There will be two (2) rounds of winner selections, and a total of 50 winners will be selected from the pool of Eligible Participants.

- a. Eligible Participants will be assigned a running number starting from serial number “1” for each entry earned and according to the date and time the Eligible Criteria is met, provided the Qualifying Criteria is fulfilled.
- b. The serial numbers allocated to each entry will be tabulated to determine the total serial number. The total serial number will then be divided by the number of Prizes to be given out to determine the number which will be used as a multiplier to select the shortlisted Eligible Participants (“**Shortlisted Participants**”).

Example for Grand Prize Winner selection:

- (i) Total entries is 5,000.
 - (ii) 5,000 will be divided by 25 which equals 200 (round down).
 - (iii) Entries assigned to Eligible Participants with the serial number in the multiplier of 200 (i.e. 200, 400, 600 etc.) will be selected as Shortlisted Participants.
- c. The Shortlisted Participants will be notified via a phone call on the necessary steps of claiming their prize within one (1) month from the last day of the Campaign.
- d. In the event a Shortlisted Participant fails to answer or respond to the call after two (2) attempts made by Allianz Malaysia, another Shortlisted Participant will be selected.
- e. Following the phone call, the Shortlisted Participants are required to reply to the email from Allianz Malaysia with the relevant information and documents requested for redemption purposes, within the stipulated date and time provided in the email by Allianz Malaysia to complete the prize redemption requirements (“**Redemption Requirements**”).
- f. In the event a Prize Winner fails to reply to the email within the stipulated date and time provided in the email from Allianz Malaysia, the Prize will be deemed forfeited.
- g. The first (1) Shortlisted Participants whose identities have been verified and who have completed all the Redemption Requirements will be the Winner of the Grand Prize. The subsequent twenty-four (24) Shortlisted Participants who meet the same verification and Redemption Requirements will be the Winners of the Special Prize for each Burst.

2. The selection of Winners shall be final, and each Winner is entitled to one (1) Prize only.

3. For the avoidance of doubt, Eligible Participants who earned Entries in Burst 1 but did not win any Prizes will have their Entries automatically carried forward to participate in Burst 2, provided the Qualifying Criteria is fulfilled. If the Eligible Participants purchase additional policy(ies) in Burst 2, the new Entries will be combined and counted together with the Entries from Burst 1.

4. The Winners' full names will be announced on Allianz Malaysia's corporate website at www.allianz.com.my ("**Announcement**") by [15 June 2026] for Burst 1 and [1 October 2026] for Burst 2.
5. The Prizes awarded exclusively to the named Winner and are strictly non-transferable, non-endorsable, non-reroutable, non-refundable and not exchangeable for cash under any circumstances and the Prizes will only be given to the Winners as verified by Allianz Malaysia.
6. In the event a Winner rejects, forgoes or fails to claim or redeem the Prize for any reason whatsoever, the Winner will disclaim all rights, interests and claims to that Prize, and Allianz Malaysia reserves the right, at its sole discretion, to deal with the Prize as it deems fit.
7. Allianz Malaysia shall give no assurance or satisfaction guaranteed with regard to the Prizes.
8. Allianz Malaysia shall not be liable for any loss, injury, or damage arising from participation in the Campaign or use or delivery of the Prizes.
9. Prize images shown in any marketing and advertisement materials are for illustration purposes only and may vary in certain aspects from the actual Prize received.
10. Allianz Malaysia reserves the right to request documentation or written proof of identification, age, and place of residence of any or all Winners of this Campaign before awarding the Prizes.
11. The Winners may be required to attend a prize giving ceremony and, for which Allianz Malaysia shall notify the Winners regarding the specific date, time and venue. All transportation, accommodation, personal expenses, and any other costs incurred in relation to attending the prize giving ceremony shall be the responsibility of the Winners. If a Winner is unable to attend the prize giving ceremony, the Winner shall provide a written notice to Allianz Malaysia at least seven (7) days in advance. Failure to do so will result in the forfeiture of the Prize.

The Winners of this Campaign shall be responsible to contact Allianz Malaysia in writing within ten (10) days from the date of Announcement in the event they have not received their respective Prizes. Any request for reimbursement of the Prize not received or delayed that is not due to the fault of Allianz Malaysia, shall not be entertained.
13. Allianz Malaysia reserves the absolute right to change and/or substitute any of the Prizes, for this Campaign with other prize(s) of similar value at any time with or without any prior notice or reason.
14. Allianz Malaysia shall reserve the rights to use the names and/or photographs of the Winners as materials for the purposes of publicity, without any prior notice. By participating in this Campaign, the Winners consent to such use and acknowledge that they shall not claim ownership or request any forms of compensation for these materials or publicity.

Part F: General Terms and Conditions

1. By participating in this Campaign, the Eligible Participants hereby agree to be bound by these terms and conditions stipulated herein and all decisions made by Allianz Malaysia shall be final, conclusive and absolute and no appeals and related correspondence in relation to the decisions of Allianz Malaysia will be entertained.
2. Allianz Malaysia reserves the absolute right and discretion to disqualify an Eligible Participant from this Campaign in the following events if:
 - (a) the Eligible Participant fails to comply with the terms and conditions of this Campaign stipulated herein;
 - (b) the Eligible Participant is found or suspected to have done anything which is in conflict with the terms and conditions of this Campaign and/or its process or operations, including but not limited to fraudulent activities involving any act of deceit and/or deception and/or cheating with regards to the participation of this Campaign; or

- (c) the Eligible Participant is found or suspected to have provided any information that is untrue, inaccurate and/or incomplete.

For the avoidance of doubt, the above list of events is non-exhaustive. Allianz Malaysia is entitled to exercise its rights and discretion as it deems fit.

3. Allianz Malaysia shall not be liable for any losses or damages whatsoever suffered by the Eligible Participants or any third parties, whether directly or indirectly, arising out of or in connection with this Campaign.
4. Allianz Malaysia shall not be responsible or liable for any loss, damage, claim, injury, death or accident incurred or suffered, in any circumstances, by the Winners, their Travel Companions or any third parties, whether directly or indirectly, arising out of or in connection with the trip taken as redeemed under this Campaign.

Allianz Malaysia shall not be liable for the specific terms of use applicable to the Prizes, or any rules or regulations stipulated by the Authorised Travel Agency to arrange for the redemption or collection of the Prize, or the benefits and/or services provided by any third-party service providers under this Campaign.
6. Allianz Malaysia reserves the absolute right and discretion to cancel, terminate or suspend this Campaign or vary its terms and conditions without any prior notice or reason. For the avoidance of doubt, the Eligible Participants hereby agree that they are not entitled to any form of compensation whatsoever arising from all losses or damages incurred as a direct or indirect result of the said cancellation, termination, suspension, or variation by Allianz Malaysia.

By participating in this Campaign, the Eligible Participants agree and consent to allow their personal data being collected, processed, and used by Allianz Malaysia Berhad, Allianz Life Insurance Malaysia Berhad and/or Allianz General Insurance Company (Malaysia) Berhad (collectively, "**Allianz Group of Companies**") in accordance with the Personal Data Protection Act 2010. In addition, the Eligible Participants agree and consent to their personal data or information being collected, processed, and used by Allianz Group of Companies for the following purposes:
 - Operations and administrative process of this Campaign;
 - Update Allianz Group of Companies records;
 - Market research and statistical analysis and surveys with the aim of improving Allianz Group of Companies products and services;
 - For advertising and promotion purposes; and
 - For any purposes required by law or regulation.

If the Eligible Participants wish to cease receiving any Allianz Group of Companies' marketing material or no longer wish to be contacted for marketing and promotional purposes by Allianz Group of Companies, please send an email to customer.service@allianz.com.my. Please note that Allianz Group of Companies will take two (2) to four (4) weeks to comply with such request.
8. The terms and conditions herein shall prevail over any inconsistent terms, conditions or representations contained in any other materials, including but not limited to promotional or advertising materials, for this Campaign.
9. The terms and conditions of the Campaign shall be governed and interpreted in accordance with the laws of Malaysia and are subject to the exclusive jurisdiction of the courts of Malaysia.
