

## **ALLIANZ MEDICURE FREE PULSE OXIMETER GIVEAWAY**

### **TERMS AND CONDITIONS**

The Allianz MediCure Pulse Oximeter Giveaway Campaign ("**Campaign**") is organized by Allianz General Insurance Company (Malaysia) Berhad ("**AGIC**") and shall be subject to the Terms and Condition herein.

#### **1. CAMPAIGN PERIOD**

- (a) This Campaign will run from 1 October 2021 until 10 December 2021 ("**Campaign Period**").
- (b) Notwithstanding the above, AGIC reserves the right to change the Campaign Period without prior notice.

  - (ii) New customers who purchase the Allianz MediCure policy within the Campaign Period;Provided always that the Allianz MediCure policy coverage commences within the Campaign Period.
- (b) The individuals who meet the above criteria shall be automatically eligible to participate in this Campaign.
- (c) Upon purchase of the Allianz MediCure policy during the Campaign Period, the Eligible Customer will be entitled to receive one (1) pulse oximeter unit. For the avoidance of doubt, where the Allianz MediCure policy purchased is a group policy, the Eligible Customer will only be entitled to one (1) pulse oximeter unit regardless of the number of individuals covered under the group policy.

#### **3. GIVEAWAY OF TEST KIT**

- (a) Each Eligible Customer will be sent a pulse oximeter via postage according to the address given to AGIC during the purchase of the Allianz MediCure policy.
- (b) The pulse oximeter is not exchangeable and/or transferable for cash or any other form of payment in kind.
- (c) Each Eligible Customer shall be entitled to only one (1) pulse oximeter even if covered under more than one (1) Allianz MediCure policy throughout the Campaign Period.

- (d) AGIC reserves the right to vary or amend these Terms and Conditions and/or substitute or replace the pulse oximeter with items of similar value without any prior notice.
