

## **Allianz Business Shield Fire Blanket Campaign Terms and Conditions**

**Allianz Business Shield Campaign** (“**Campaign**”) which is organised by Allianz General Insurance Company (Malaysia) Berhad (“**AGIC**”) is offered to policyholders with property(ies) covered under the **Allianz Business Shield – Motor Showroom & Workshop Package** or **Allianz Business Shield policy with Medical Professional Liability Insurance for Clinics** policy (“**Eligible Policy**”) issued through any distribution channel of **AGIC**. This **Campaign** is subject to the following terms and conditions.

### **1. Campaign Period**

This **Campaign** will run from 1<sup>st</sup> July 2025 to 30<sup>th</sup> September 2025 or until the total number of fire blankets to be given away under this **Campaign** reaches two thousand (2,000) units, whichever is earlier (“**Campaign Period**”). This giveaway is on a first come first serve basis.

### **2. Campaign Eligibility**

The following are the criteria to be eligible for this **Campaign**:

- a) This **Campaign** is open to all policyholders who either:
  - (i) have purchased an **Allianz Business Shield – Motor Showroom & Workshop Package**; or
  - (ii) have an **active Allianz Business Shield policy** and add on the **Medical Professional Liability Insurance for Clinics** policy, during the **Campaign Period**.
- b) Valid contact details of the policyholder such as mobile number and email address must be provided to **AGIC** during the purchase of the **Eligible Policy**.

- c) The policyholder who fulfils the criteria above will be eligible for the giveaway under this **Campaign ("Eligible Participant")**.

### 3. Campaign Giveaway

Each **Eligible Participant** shall be entitled to receive **one (1) fire blanket**, which will be sent within **thirty (30) working days** from the policy issuance date. Only two thousand (2,000) units of such fire blankets are available to be given away during the **Campaign Period**.

### 4. Other Conditions

- a) By participating in this **Campaign**, the **Eligible Participant** hereby agree to be bound by the terms and conditions, and any decisions made by **AGIC** in respect of this **Campaign** which shall be final and conclusive.
- b) **AGIC** reserves the right and has the absolute discretion to cancel, terminate or suspend this **Campaign** or vary its terms and conditions without any prior notice or reason. For the avoidance of doubt, the **Eligible Participant** hereby agree that they are not entitled to any form of compensation whatsoever arising from any losses or damages incurred as a direct or indirect result of the said cancellation, termination, suspension or variation by **AGIC**.
- c) **AGIC** shall not be liable for the specific terms of use which may be applicable to the fire blanket, or any other item given away under this **Campaign**.
- d) **AGIC** shall not be liable for any direct or indirect loss or damage of any kind howsoever arising, suffered by the **Eligible Participant** or any person claiming through the **Eligible Participant** in connection with this **Campaign**.
- e) The processing of any personal data provided pursuant to this **Campaign** shall be in accordance with the Personal Data Protection Act 2010.
