

Allianz “Special Offer on Drive Guard” Campaign Terms and Conditions

The “Special Offer on Drive Guard” Campaign (“**Campaign**”) is organised by Allianz General Insurance Company (Malaysia) Berhad (“**AGIC**”) and shall be subject to the terms and conditions contained herein.

1. Campaign Period

This **Campaign** will run from 3rd March 2026 to 31st December 2026 (“**Campaign Period**”). Notwithstanding the aforesaid, **AGIC** reserves the right to change the **Campaign Period** without prior notification.

2. Campaign Eligibility

To be eligible to participate in this **Campaign**, the following criteria must be met:

- a) The individual Allianz Private Car (Comprehensive) Motor Insurance policy (“**Policy**”) must be purchased or renewed during the **Campaign Period**;
- b) The Drive Guard add-on coverage (“**Drive Guard Coverage**”) must be purchased under the **Policy**; and
- c) The quotation must be issued within the **Campaign Period**. For example, a quotation issued on or before 2nd March 2026, with a **Policy** effective date of 3rd March 2026, shall not qualify for entitlement under this **Campaign**.

The policyholder who fulfills the criteria above will be deemed an eligible participant (“**Eligible Participant**”) and will enjoy a premium discount on the **Drive Guard Coverage** under the **Policy**, subject to the **Campaign** terms and conditions.

3. Campaign Terms and Conditions

- a) This **Campaign** shall not be applicable to **Policies** where the policyholder is a corporate entity/group (e.g., companies, societies, associations, etc.).
- b) **Eligible Participants** shall be entitled to purchase the **Drive Guard Coverage** at a discounted premium of RM5 (“**Discounted Premium**”).

Coverage	Sum Insured
Death and Permanent Disablement due to an Accident	RM50,000
Hospital Income	RM50 per day / up to 60 days
Medical Expenses	RM2,000
Bereavement Allowance	RM2,500

- c) In the event the **Eligible Participant** purchases more than one (1) **Policy** during the **Campaign Period**, he/she will be entitled to enjoy the **Drive Guard Coverage Discounted Premium** for each **Policy** purchased.
- d) All other conditions shall be subject to the benefits stated in **the Eligible Participant's** policy schedule and policy wording.

4. Other Conditions

- a) By participating in this **Campaign**, the **Eligible Participants** hereby agree to be bound by the terms and conditions stipulated herein and all decisions made by **AGIC** in respect of this **Campaign** which shall be final and conclusive.
- b) **AGIC** reserves the absolute right and discretion to cancel, terminate or suspend this **Campaign** or vary its terms and conditions without any prior notice or reason. For the avoidance of doubt, the **Eligible Participants** hereby agree that they are not entitled to any form of compensation whatsoever arising from any losses or damages incurred as a direct or indirect result of the said cancellation, termination, suspension or variation by **AGIC**.
- c) **AGIC** shall not be liable for loss or damage whatsoever suffered by the **Eligible Participants**, whether directly or indirectly, arising out of or in connection with this **Campaign**.
- d) The processing of any personal data provided pursuant to this **Campaign** shall be in accordance with the Personal Data Protection Act 2010.
